P/14/15 Minutes of the previous Meetings
The minutes of the meeting held on 28 January 2015 were **AGREED** as a true record.

ACTION: The Clerk to write to Highways requesting that they look at the path between Rosemary Gardens and Golden Square regarding the overgrown hedge and ask for a plan of the town.

Street lighting update – Cllr Kemp and the Clerk had met with WSCC and SSE. WSCC are giving £6k to PTC towards the cost of the historic lights. Cllr Kemp is due to speak to the Estate as the wrong fitting had been erected on the obelisk and SSE have agreed to correct it. WSCC and SSE have proposed putting an additional light in Golden Square. The question is whether to restore the lights to their original Victorian gas design or to the 1930's design when they changed to electricity. Lady Egremont and The Petworth Society will be consulted.
